Direct Awards

As a certified Service-Disabled Veteran-Owned Small Business (SDVOSB) under the Small Business Administration (SBA) Veteran Small Business Certification (VetCert) program, RB Consulting, Inc. (RBCI) is eligible to receive direct awards under SBA Small Business Program direct award authority. We may accept direct awards resulting in sole source contracts up to \$5M.

3 Easy Steps

- 1. The Government Program Manager prepares a procurement request and submits it to the agency Contracting Officer (KO). This request includes a performance work statement (PWS), cost estimate, and funding.
- 2. The KO sends an offer letter and the PWS to RBCI's SB point of contact (POC). The SBA POC processes the offer letter and returns it to the KO within 5 business days.
- 3. The KO issues a Request for Proposal (RFP) to RBCI. We submit a proposal, the Government awards the contract, and we begin the work.

This entire process can be completed in 5-10 business days or less.

Sole Source Requirements

The Veterans Benefits Act of 2003 (Public Law 108-83) established a procurement program for SDVOSBs, and FAR 19.1406 allows sole source awards to SDVOSBs under the following conditions:

- Only one SDVOSB can satisfy the requirement.
- The award will be less than \$4M (\$5M for the Department of Veterans Affairs [VA]).
- The SDVOSB is a responsible contractor. (i.e., it can perform the work).
- The work is not currently being performed under the SBA 8(a) program.
- The price is reasonable.
